# Additional Terms for Adam Point

In order to use Adam Points issued by us, users must read and agree to these terms and conditions (hereinafter referred to as the "Additional Terms for Adam Point").

# Section1 (Scope of application)

Additional Terms for Adam Point stipulate the handling of Adam Points issued by us. Any matters not stipulated in Additional Terms for Adam Point shall be stipulated by the Adam by GMO Terms and Conditions.

### Section2 (Definition)

Terms used in Additional Terms for Adam Point shall have the meanings set forth below, in addition to being in accordance with the Adam byGMO Terms of Service.

- (1) The term "Additional Terms for Adam Point" means these Adam Point Terms and Conditions.
- (2) "Adam Point" refers to a prepaid means of payment issued by us and corresponds to an individual service of Adam byGMO.
- (3) "Item Sales" means the total amount of money received by a user from the sale of items held by the user as a secondary seller.

#### Section3 (Scope of use)

- 1. Only residents of Japan are eligible to recharge and use Adam Points.
- 2. Adam Points can be used to access Adam byGMO and pay for items on Adam byGMO within the limit of the Adam Point balance in accordance with the provisions of Article 5. However, depending on the status of the secondary seller (merchant), some items on the secondary listing may not be paid for using Adam Points.

#### Section4 (Adam points issued)

- 1. Adam Points can be recharged at Adam byGMO using a credit card or item sales proceeds as specified by us.
- 2. Adam points can be charged in increments of 1 yen and it has to be over 1,000 yen for credit card purchases, and in increments of 1 yen or more for item sales.
- 3. The maximum amount of Adam Point charge and balance is 1,000,000 yen.
- 4. Users shall confirm the amount to be charged in advance when recharging Adam Points. Charges cannot be cancelled or refunded for any reason.

# Section5 (Use of Adam Points)

- 1. Users may use Adam Points to pay for items by accessing Adam byGMO and logging in to their user account with their ID and password.
- 2. Adam points can be used in 1 yen increments.
- 3. After the transaction contract is concluded, if the user expresses the intention to use Adam Points for payment of all or part of the item price, and if we approve this, the payment for the item price will be deducted from the Adam Points balance, up to the Adam Points balance, and the payment for the item price will be deemed to have been made. The payment will be considered as payment of the amount of the item price.
- 4. In the case of the preceding paragraph, the amount paid for the item and the balance of Adam Points after payment will be displayed on My Page, and the user should confirm that there are no errors in them.
- 5. If the balance of Adam Points presented by the user is less than the amount of the item price, the payment for the item price will not be completed, and the payment shall be made separately by other means.

# Section6 (How to check your Adam Points balance)

You can check your Adam Point balance by accessing Adam by GMO and logging in to your user

account with your ID and password.

### Section7 (Adam point refunds, etc.)

Adam Point balances are non-refundable and non-exchangeable for cash. However, in the event that the handling of Adam Points is completely discontinued due to the enactment, amendment, abolishment, or reinterpretation of laws and regulations, or due to a business necessity of us, the balance of Adam Points will be refunded to the user in the manner prescribed by us.

### Section8 (Suspension of Adam Point usage)

We may suspend the use of Adam Points or revoke Adam Points in any of the following cases

- (1) When a user obtains Adam Points by fraudulent means or uses Adam Points knowing that they were obtained by fraudulent means
- (2) If the Adam Point is counterfeit or altered
- (3) If the user violates any of these individual terms and conditions
- (4) When a user's user account is suspended or deleted
- (5) In addition to the above, if the Company determines that there are reasonable grounds for suspending the use of Adam Points.

### Section9 (Adam point usage period)

Adam Point usage period is one year from the date of Adam Point recharge. Please note that Adam Points will expire and cannot be used after the usage period. In this case, no refund will be made regardless of the Adam Point balance.

# Section 10 (Discontinuation or suspension of Adam Points usage)

We may suspend or discontinue the use of Adam Points without notice in advance to users when We deems it necessary to suspend or discontinue the system due to system maintenance, Internet, system or computer failure, or information security incidents.

# Section11 (Prohibition of transfer, etc.)

Adam Points may not be transferred or otherwise disposed of, pledged or otherwise encumbered.

### Section12 (Compensation)

Any loss incurred by the user due to unauthorized charging, use or disposal of Adam Points shall be subject to the "Policy on Compensation for Losses Due to Unauthorized Transactions," which is separately stipulated.
